Bidding documents may be purchased at the given address below within 30 days from the date of publication at office hours, Musikot Municipality, District Administration office, Treasury controller office, Rukum by interested eligible Bidders on the submission of a written application along with the copy of company/firm registration certificate, Local body business registration certificate, Tax learance up to FY 071/072 and upon payment of a non-refundable fee of Rs. 1,000.00 (in words s one thousand rupees only) deposited at current account no. 07703000000003000005 of Musikot

Municipality at Nepal Bank limited, Rukum.

Sealed Bids must be submitted to Musikot Municipality office on or before 12.00 hours on 31st day from the date of publication. Documents received after this deadline shall not be accepted.

The figure for the bid amount must be clear if any discrepancy may occur then the figure written in word is valid.

Bids shall be opened in the presence of Bidders' representatives with original related documents. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security amounting to a minimum of 2.5 % of the quoted Bid amount (Inclusive Nepal Bank limited, Musikot, Rukum, or bid bound authorized from recognized commercial bank of Nepal, which shall be valid for minimum 30 days within the bid validity period.

If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
