1. *Office of the Musikot Municipal Executive, Musikot, Rukum (West)* invites electronic bids from eligible bidders for the **Construction of Rugha Khola Sheetal Bazar Road Bridge** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 40000000.00**
 - Minimum Work experience of similar size and nature: **1 no. of NRs. 26644000.00**

Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

4. Pre-bid meeting shall be held at **Sama Office** at 11:00 O'clock, 2080.11.24 B.S.
5. Electronic bids must be submitted to the **Office of Musikot Municipal Executive, Musikot, Rukum (West)** through PPMO's e-GP system www.bolpatra.gov.np/egpon or before 12:00 O'clock on 2080.12.05 B.S. (2024.03.18 A.D.). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 O'clock on 2080.12.05 B.S. (2024.03.18 A.D.) at the **Office of Musikot Municipal Executive, Musikot, Rukum (West)**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 1500000.00, which shall be valid for 30 days beyond the validity period of the bid i.e. 2081.04.02 B.S. (2024.07.17 A.D.).
7. Technical Proposal Format i.e. Form PER 1, Form PER 2, Form EQU etc. and Bidder's Qualification Format i.e. Form ELI 1, ELI 2, ELI 3, Form LIT 1, Form FIN 1, FIN 2, FIN 3, FIN 4, FIN 5, Form EXP 1, EXP 2(a), EXP 2(b) should be filled properly and signed .
8. **Tax Clearance Certificates** should be submitted with **Audited Income Statement and Balance Sheet** accordingly.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
