1. The Government of Nepal [GoN], **Musikot Municipality** Office has allocated funds towards the cost of following projects and intends to apply part of the funds to cover eligible payments under the Contract for following projects. Bidding is open to all eligible Nepalese Bidders.
2. **Musikot Municipality** Office invites sealed bids or electronic bids from eligible bidders for the following projects under National Competitive Bidding procedures.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the **Musikot Municipality Office, Musikot Ward -05** Phone NO:088-530261.
4. A complete set of Bidding Documents may be purchased from the office of Musikot Municipality Office, Musikot Ward no-05, Rukum (West) and Phone NO:088-530261 by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and up on payment of a required fee till **30th day from First Published Date during office period**. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 10,000. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.
5. **Pre-Bid meeting** will be held at the 10 days before the last date of submission of bid.
6. Sealed must be submitted to the **Musikot Municipality Office, Musikot, Ward No. -05, Rukum (West)** by hand/courier before **12:00 hours on 31st day of Publication**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hours on 31st day** at the Musikot Municipality Office. If the bidder's representative **does not choose** to attend for opening, there will be no objection in opening the tender.
8. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security amounting to a minimum of 2.5% of estimated amount, which shall be valid for **30 days** beyond the validity period of the bid. If the bidder wishes to submit the bid security in the form of cash, the amount should be deposited in **Nepal Bank Limited, Musikot**

9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
